## All Brokers Must Complete 18 Hours of Broker CE

Effective July 1, 2025, all Brokers, Qualifying Brokers, and Associate Brokers must complete 18 Hours of Continuing Education courses specifically approved as Broker CE in order to renew a License.

These 18 hours must be completed before renewing any Broker or Associate Broker License. There are no reciprocal courses from other states than can meet this CE requirement. To locate schools offering Broker CE, view the list of [Approved Real Estate Schools](#) and you can scroll to see those offering Broker CE and click on the School website or call their stated phone number for further information.

The one exception to this requirement is for Licenses that are "grandfathered" and not required to take CE, those licensed before January 1, 1980.

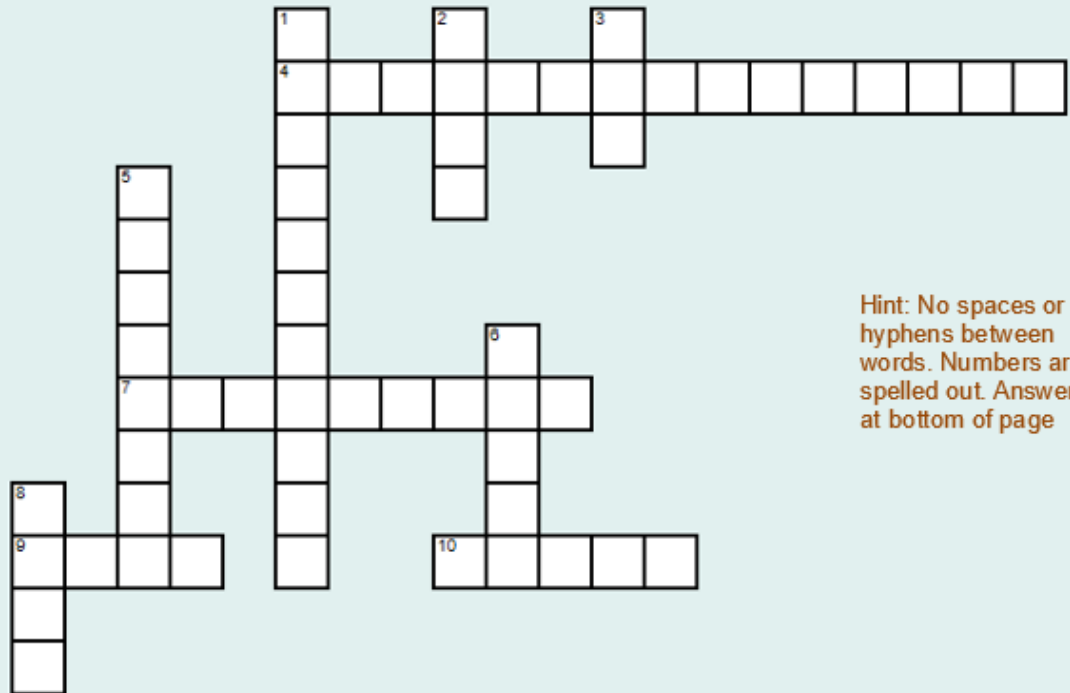
