Once the completed application is received, including all supporting documents, the application will be processed. An application requiring a background investigation will require additional time to process. Incomplete applications will be returned unprocessed and result in a \$25.00 charge.

Your renewal can be done online at www.grec.state.ga.us, using a credit card for a reduced fee. If you successfully renew online, DO NOT SUBMIT THIS APPLICATION.
