Attach a notarized **"Lawful Presence Verification"** form, along with a secure and verifiable document, as noted on our website, www.grec.state.ga.us, **if not already on file with the GREAB**.

The *former Director* completes and signs section **B**, which releases the Director from the School and updates the School record. If the former Director is not available to sign, attach an official letter from the School releasing him/her.
